

Loss Control Consultants	Loss control consultants provide annual on-site visits to each city over population 700. Visits focus on an annual liability or safety survey. They also review loss reports, address other concerns members may have, and respond to various requests throughout the year. That includes ergonomic reviews, providing resources for safety programs and trainings, developing risk improvement plans, and providing individualized consulting services. Cities under population 700 receive an annual phone call and ongoing communication from LMCIT's Loss Control Program Coordinator, in which concerns are discussed and additional resources are provided as needed. Regional Safety Groups (RSGs)	Regional Safety Groups give smaller cities the opportunity to partner with neighboring communities to meet state and federal OSHA mandates. Each Regional Safety Group chooses dates, locations, and topics to create their own customized training calendar. LMCIT partners with the Minnesota Municipal Utilities Association (MMUA) to deliver these services.
Peace officer Accredited TRaining OnLine (PATROL)	LMCIT has developed a comprehensive online training program for Minnesota law enforcement agencies. This platform contains 60 one-hour courses, all approved by POST for continuing education credits. Physical Abilities Test	LMCIT and a police-led steering committee created a pre-employment, post-offer abilities test for police officer candidates. It was developed by WorkSTEPS and administered by NovaCare in most locations. This test is available to any police department in Minnesota. Public Safety Mental Health	The Public Safety Program Coordinator focuses on promoting first responder mental wellness and reducing workers' compensation costs, specifically related to Post-Traumatic Stress Disorder. Safety and Loss Control Workshops	Each spring LMCIT holds a series of one-day workshops at locations throughout the state. These sessions focus on providing practical information for cities to help avoid losses and reduce the costs of losses that may occur. Several tracks are offered for various staff, including public works, fire, peace officers, administration, and parks and recreation. Workshops are held in the fall as well, although those are more specialized, focusing on various law enforcement-related issues in recent years. 
